South - EHCP Provision

We have had feedback from parents who feel that their child/young person is not receiving the provision in their child/young person's EHCP (Education Health Care Plan) If you feel your child's EHCP provision is not being met, you can contact SENDIASS (Special Educational Needs and Disabilities Information, Advice, and Support Service) for support:

South - Post 16 Transport

Some parents say they are concerned that transport provision seems to stop when their child reaches 16, despite many needing to access education settings until they are 19.

Transport provision for Post-16 is governed by statutory guidance, meaning Essex County Council (ECC) has not made this decision independently. However, you can still apply for travel support and request Travel Training.

Mid Essex - Shortbreaks

Shortbreaks registration process and SEND Sensation information about holiday/weekend clubs is not user friendly, quite daunting to access and not much available for under 8s in Chelmsford. Holiday clubs are difficult to access for working parents due to hours.

This will be fed back to the Shortbreaks and SEND Sensation teams and an update will follow shortly.

North East Essex - ADHD Medication

Parents and carers have raised concerns/confusion regarding changes to GP's prescribing ADHD medication.

During the North East Essex Neurodevelopment Oversight Group meeting this was discussed. We are currently waiting updated communications from ESNEFT regarding this and will share this when these are released.

Essex Wide - Accessing a Blue Badge

We received feedback that accessing a Blue Badge through the LA for hidden disabilities was a difficult process. Essex Local Authority shared the following:

The Department for Transport guidelines state "Aside from cases where an applicant is unable to walk; i.e. that they cannot walk during the course of a journey, it should be remembered that "very considerable difficulty whilst walking" and "serious harm" during the course of a journey are **high thresholds** that should be applied to all applicants equally, whether their disability is visible or non-visible ('hidden')" Therefore, Applications submitted under the non-visible (hidden) disabilities criteria must be supported by a supplementary hidden disability evidence form, completed by a professional, fulfilling the role of an expert assessor, involved in the diagnosis, treatment, or provision of ongoing therapeutic services. A covering letter from the professional is also required, confirming they have provided the supporting evidence, and their involvement with the applicant. Examples of professionals who can complete the form include, but are not limited to, a clinical



psychologist, educational psychologist, neurologist, occupational therapist, psychiatrist, rheumatologist, social worker, SENCO, or mental health nurse. These interviews were for professionals hoping to study for a doctorate in Clinical Psychology, and would be part of the Mental Health teams covring the whole of Essex, including services that support individuals with SEND. There were some really strong candidates who went through the rigorous selection process, who were able to demonstrate their appreciation for the service user journey, the challenges that may bring, and also what they may be able to address in their practise to ensure that barriers to successful outcomes are overcome, individuals feel supported, and the service meets needs. It was a very informative day and really positive to meet so many dedicated an committed professionals, who were keen to ensure they were able to deliver the best for their service users.

 positive effect from the project is the community it has created amongst parents, they
 feel more supported by one another and grateful for schools getting involved and
 improving their level of understanding of Neurodiversity.
